## **TERMS AND CONDITIONS**

The following are Terms and Conditions for the Sale of Goods that will govern any contract for sale that we enter into with you. Please read these Terms and Conditions carefully.

1. The price you will pay for the goods is shown in the bottom right of the Shopping Cart.

2. Once you wish to purchase the goods in your Shopping Cart, you can proceed to a "Checkout Screen" where you will be asked for your payment details.

3. By completing the details and clicking the "Confirm Order" button, you are offering to buy the goods subject to our terms and conditions and this purchase procedure.

4. Goods are subject to availability. If we do not supply the goods for any reason we will refund any money already paid for the goods. However, we will not be responsible for compensating you for any other losses which you may suffer if we do not supply goods.

5. We will endeavor to deliver goods within the times stated. However, goods are subject to availability and delay in delivery of goods is sometimes outside of our control. Any dates we specify for the delivery of the goods are approximate only and we shall not be liable for any losses, costs, damages, charges or expenses caused by any delay for delivery of the goods unless caused by our negligence.

6. Should delivery be delayed for more than twenty-one (21) days, you have the right to contact us and refuse to accept the goods. In this case we will refund any money paid by you for the goods.

7. As soon as we have received the goods you will be responsible for them. If you delay accepting a delivery, our responsibility for everything other than damage due to our negligence will end on the date the carrier tried to deliver the goods to you. If the goods are returned to us by the carrier all shipping fees, to reship your order, must be prepaid in advance.

8. Important Notice: Time limit for notification of claims. If goods arrive in a damaged condition you must inform us within three (3) days. Our customer care department will arrange collection of these goods and we will replace the goods at no charge upon our receipt of the damaged goods. If you fail to do this we shall have no liability for goods said to be damaged on delivery. If the goods returned under this clause are found to be in full working order, the goods will be returned to you and an administration fee of 20% of the price of the goods along with the cost of shipping will be charged to you.

9. The price for the goods will be as stipulated at the time when you place your order. We are entitled to make future adjustments to the price to take account of any increase in our supplier's prices, or the imposition of any new taxes or duties. However, if due to an technical error or omission the price published for the goods on our website is wrong, we will inform you of the correct price and give you an opportunity to cancel the order.

10. At our absolute discretion we have the right to terminate any contract between us without penalty within 14 days from the date we accept your order. In the event of termination we shall refund to you all sums paid by you.

11. You will be the rightful owner of the goods once we have received payment in full.

12. We do not offer any credit facilities. We will issue you with an electronic invoice once we have received payment in full for your order.

13. We guarantee the goods are free from defects in materials and workmanship, subject to our guarantee, for a period of ninety (90) days from the date of delivery.

14. Failure by us to enforce any of these Terms and Conditions will not affect our right to enforce the rest of these Terms and Conditions.

15. The contract between us shall be governed by the laws of the State of Georgia. Any dispute will be resolved exclusively in the courts of the State of Georgia. We will to try to resolve disputes when they first arise without the necessity of legal remedies. If you have a complaint contact Customer Services.
